6. New Business

A) Review of New Meeting Support - Scott C.

Motion to specify that a "New Group Packet" will be distributed to each new group as they register at WSO and in the Region. A New Group Packet has the value of \$35 (the total value is \$44.10 to include shipping and tax).

Scott C made motion, Laura seconded, after discussion motion was withdrawn by Scott C as it would have required the CCR to provide both the New Group Packet and \$50 start-up funds as voted on by group conscience at previous meeting. After discussion it was determined the CCR commitment at \$94.10 is excessive and not currently included in our budget.

- B) Report on the choice of a venue in Santa Barbara, August 8, 2015 at 1:00 PM. Scott N. Scott N reported an option of a venue. After discussion Scott N made a motion to rent Lutheran Church for Assembly at an expense of \$50, Chantal seconded motion, approved unanimously
- C) Report on the progress of the Subcommittee to Guide to Region Services Michael F.

 Michael was not present to provide verbal report, however the written report has been uploaded to Yahoo Groups. Group members present agree with submission with a change to reflect the vote will be held at the August Assembly.
- D) Open discussion about assembly length, time of day, cost to GSRs.

Chantal as Delegate reported the financial hardship (travel and hotel expenses) for GSRs to travel to night Assembly in January. Scott N reported that SCR Al-Anon pays for mileage over 100 miles and a reimbursement for hotel expenses per GSR for Assemblies (\$80 approx). The reimbursement for the first 100 miles is provided by the group. After discussion, there are plans to craft a motion for the Assembly to provide assistance for groups for mandatory inperson meetings which will require a change to the budget. Also was discussion regarding expense incurred by the Delegate to travel to meetings and how travel reimbursements will be handled. As a new Region, this needs to be addressed in our GRS and estimate to be determined (using the IRS mileage calculation) and included in budget. Tony will take lead and send email request for members on Budget Committee to address changes during the May 20 6pm Skype meeting.

Report of the AdHoc Subcommittee to draft a Guide to CCR Services

Submitted to the Central California Region Regional Service Committee on 4/11/15.

Dear Chairman:

Per the First (1st) Central California Region Assembly Motions 10-A & 10-B:

A10-A) adopt the Guide to Local Services (GLS) and Guide to World Services (GWS) as guiding documents for Central California Region (CCR).

B10-B) create an AdHoc Committee to draft a Guide to Regional Services (GRS) and report back at our next Assembly (2nd).

The Subcommittee volunteers are Tony, Chantal, Sandi, Michael, and Scott N.

After near weekly meetings and diligent work by the Subcommittee, the effort to draft the CCR GRS continues with great progress and is close to completion.

This effort continues to be a great learning experience for all the members of the Subcommittee in learning about intricacies to the purposes of establishing a clear and concise CCR's GRS.

The GLS, in suggesting how to structure the CCR's GRS, states the Regional shall follow the GLS Regional Structure as put forth in the GLS; however the Committee members are discerning inadequacies in the GLS and are attempting to:

- 1. Improve the CCR's GRS functionality by composing a more comprehensive GRS tailored to the specific conditions unique to this region.
- 2. The Committee has been committed to the goal of creating a document that will stand the test of time with minimal future changes being necessary. It is crafting language that addresses potential occurrences with specific language to address such occurrences. The purpose is to minimize future discussions of the intent of the document and thus minimize disruption in the course of performing the Region's business.

The Committee goal is to present the CCR 3rd Assembly a Draft GRS for either future guidance in developing portions of the document, or outright approval.
