## 3. Adoption of Minutes of Previous Assembly

A) Motion to approve minutes for the Assembly of August 8, 2015

Brenda made a motion to approve minutes as submitted, Arnie seconded, motion passed unanimously

Discussion regarding the difficulty in locating meeting minutes in Yahoo group and questioning the possibility that members don't have access unless they are part of CCR Yahoo Group. Scott explained that minutes are available on the website NaranonCentralCA.org/member services/minute archive.

## 5. Comments and Reports

- A) Chair report Scott N.
  - ~2016 World Service Conference is coming up, we are fortunate to have the process.
  - ~Mentorship is a wonderful opportunity to provide service so if you have experience in a service position please mentor those following behind you, outgoing GSRs please provide support to new GSRs
  - ~Our sole purpose is to be of service to the groups, three legacies: recovery through Steps, unity through Traditions and service through Concepts
  - i) Regional Service Committee: RSC meets twice a year, once in the spring and once in the fall, both meetings are held via Skype.

- ii) Outreach: Currently we do not have an official committee at this point although there is outreach happening on the group level. A Regional Outreach Committee would be the central point of communication for all meetings in the region coordinating efforts and providing service to groups. Scott asked if there is anyone interested in chairing the Outreach Committee recognizing that all trusted servants work within their own healthy boundaries. Sandi S volunteered for the position. Charles made a motion to accept Sandi S as Chair of the Outreach Committee, Jocelyn seconded, 8 yays, 1 nay, no abstention. Motion passed
- B) Secretary Laura T stated that she appreciates the patience of the fellowship with challenges related to creating, formatting and distributing minutes and other regional documents in a timely manner. Also, informed each GSR/AltGSR that each group is assigned a Group Number by the World Service Office, that number will be included on the new Contact list and can be found on the WSO website
- C) Treasurer Tony M discussed treasurer handouts.

Please ensure that group treasurer knows to include the name "Nar-Anon Family Groups" (or NFG) when writing out checks for 7<sup>th</sup> Tradition contributions. Checks are often being made out to only Central California Region which is not valid account name on its own. Please include the group name and # on the check. After discussion, Jocelyn recommended the creation of a form to be included when sending 7<sup>th</sup> Tradition donations. Tony, Scott C, and Jocelyn will create the document. Chantal suggested including that form in the Regional Guide to Local Services.

Tony reviewed the Treasurer Report dated 10/11/15-12/31/15 showing a beginning balance of \$3783.31 and ending balance of \$3979.77. The transactions included a deposit from the recently disbanded Monterey Area of \$1932.10 and an expense of \$1900.00 sent to the WSO for our Delegate to attend the Conference. This is an equalized expense in Nar-Anon so each meeting, regardless of location, has the same financial commitment. The Treasurer Report dated 12/31/15-1/9/16 has a beginning balance of \$3979.77 and an ending balance of \$4446.77 indicating a deposit of \$50, a 7<sup>th</sup> tradition donation from Simi Valley. This transaction was discussed as Simi Valley, through group conscience, will be leaving the Central California Region to be part of the Southern California Region but wanted to make a donation to the Central California Region prior to transition. Arnie made a motion to accept the Treasurers Report (2 documents) as submitted, JT seconded, motion passed unanimously.

Tony reviewed the document titled "Region Budget 2015" recognizing it should say 2016 (instead of 2015). Discussion included rolled over excess funds of \$1459.02. Brenda made a motion to accept the 2015 completed budget as submitted, Arnie seconded, motion passed unanimously. Janet made a motion to accept rolled over excess funds of \$1459.02 putting us over the previously approved budget, JT seconded, the motion passed unanimously. Arnie made a motion to accept carry over funds from 2015 budget to 2016 budget of \$3979.77, Brenda seconded, approved unanimously.

Tony discussed the document titled "Central California Region, NFG Assembly Meeting 1/09/15" recognizing it should read 1/09/16 (instead of "15") with suggested amendments to the 2016 budget due to some changes within the region. There is a need to do a group conscience today as budget must be approved at Assemblies (not Regional Service Committee meetings) and it will be August until the Assembly meets again. It was agreed to re-address this proposal later in the day after we had discussed region business. (The vote occurred as part of Section 5F)

- D) Group Reports GSRs
  - i) Scott opened this discussion asking each representative to share the group name and how they feel the name of the group fits the character of the group
    - Jocelyn-Santa Barbara "I Can Be Free" ~ felt last night's group was great example as the meeting topic was the tools of the program which offer freedom
    - Brenda-Scotts Valley "Sharing Experience Strength, and Hope" fits perfectly as that is what they do through Friday meeting, step groups and service to The Camp Recovery Center
    - Arnie-Monterey Tuesday "In the Solution" matches the group (18 members) as it has a history of newcomers who "keep coming back" and stepping up for service positions as they are finding solutions
    - Doris-Carmel "Serenity by the Sea" is a great name as the group members are trying to use the tools, steps and fellowship of the program to find serenity
    - Michael-Atascadero Tuesday "Candlelight Meeting" ~ was not sure of the origin of
      the name as he came to the meeting after it had started. The group was struggling
      but with his 12 step experience he recognized the opportunities for it to become
      healthy and believes the light is that members have grown in the recovery program
      through the group and tools of the program

- JT-Hollister "Stairway to Freedom" was started with the thought that there are steps to freedom. Name fits as sometimes you fall off the steps but they are always there providing opportunities to find serenity
- Cyndy-Seaside "Monday Night Miracles" ~ Cyndy was not there when group was formed but knows that miracles do happen in this small meeting (around 4 people) that is trying to find a good fit with meeting time and location
- Jason-Hollister "Guide to Serenity" is interesting as new members come in on the roller coaster not knowing how to get out of the chaos, this group provides the guide to being healthy and finding serenity
- Janet-Salinas "Sweet Serenity" can have multiple meanings, sweet could be precious or cherished, something we aspire to, can also mean serenity can be fleeting so it is sweet when we can appreciate it
- Charles-Monterey Saturday "Circle of Hope" ~ a circle is unbroken, fellowship is
  there because we love someone who struggles with addiction, meeting provides an
  infinite circle of fellowship that helps retain a level of serenity in the midst of chaos

Re assemble at 1:20, roll call conducted resulting in one voting member absent and addition of Lynn B (non-voting member Monterey) present via Skype. Brenda returned at 1:25

- E) Area Reports ASRs
  - i) Monterey Area Sandi S. reported that the Monterey Area has dissolved. Sandi brought up discussion regarding the plethora of Monterey Area documents currently on the Monterey Yahoo Groups and what to do with the few items purchased with Monterey Area funds, such as the microphone used at the Monterey Convention. Arnie made a motion to transfer all assets and resources from the Monterey Area to the Central California region, including archiving electronic documents on the CCR Yahoo Groups, JT seconded, motion passed unanimously
- F) Delegate and Alternate Delegate Chantal M.
  - i) Update on the 2016 World Service Conference (WSC) Conference Agenda Report (CAR) process and the motions to be voted on. There was a great response to the 3 Monday night Skype information sessions including members from the Southern California Region. Chantal offered to be of service to the membership in helping groups understand the

motion process. She has created a document for each group to submit to her with the group conscience with an April 1 deadline.

Jonnie spoke to the history of Narateen and reviewed the motions included on CAR which ensures we are abiding by state laws, creating structure, safety, and accountability since Narateen members are minors. Jonnie related the lengthy process other regions have gone through requiring monthly meetings setting up information on background checks and guidelines to be presented to region for approval. As the region only meets periodically throughout the year this progress can take up to a year. The conference votes will assist with creation of steps, requirements, and processes. Scott asked if there was anyone present called to chair a Narateen subcommittee? No volunteers stepped up for that service position. Scott did a straw poll to see if the region is interested in considering the creation of a Narateen subcommittee. All members support this valuable service. Arnie made a motion that CCR create a Narateen subcommittee effective January 2016, JT seconded, motion passed unanimously.

Scott informed group of the open position of Alternate Delegate, Arnie volunteered for this service position. Jocelyn made a motion to install Arnie as the Central California Region Interim Alternate Delegate, JT seconded, motion passed unanimously. Scott opened up discussion with a straw poll for interest in region for possibility of sending alternate delegate to the Conference, group agrees. Brenda made a motion to adopt the CCR Assembly Meeting amended 2016 budget suggested by Tony allowing CCR to send Arnie to the Conference as a Local Observer. Doris seconded motion, requiring a 2/3 required vote, 8 yay, 1 nay, motion passed. Arnie will be attending conference as local observer.
