- A) Chair's Report Michael F.

Michael – reported he sent a note to the WSC stating the CCR wanted to donate surplus funds from the 2020 WSC that are not being used for the CCR Delegates to attend the 2021 WSC.

- B) Outreach Janet S.

Teri – highlighted some of the points in the Delegate Report on page 21 of this packet. Teri and JT will be attending the Zoom training sessions for the WSC. April 29 through May 2 is the WSC. Teri and JT have met with the "ad hoc motions committee." Discussion continued regarding the proposed motions. Previous meetings were held on

March 7 and April 3. The CCR website is the main site to direct potential members to. The CCR site is easier to navigate than the WS website.

JT – added that the agenda for the WSC has been posted on the CCR website. If groups are interested in the floor motions, JT is open to meeting with groups and members to help them understand. One of the ways we can understand the floor motions is to read the "white papers" that have been written. Is the committee open to posting them on the CCR website?

The proposed floor motions are linked from the CCR website and the Western Regions site. They are not translated into Spanish on the CCR website, but they are on the Western Regions site.

#### Michael – took issue with the "we invite you" statement in the first sentence. It makes it

sound like CCR business when it is not.

Michael – asked who composed the email?

**Robert – said he probably composed the email.** 

Scott – agreed with Michael's take on the representation of the email as CCR business is not appropriate.

Michael - asked Robert if he would take us through the efforts of the motion's cadre. Robert took the RSC through a high-level overview of the motions. The following summaries were taken from the WRCNFG website.

Motion 1: In the Guide to World Services section "Copyright and Trademark Information", insert the following text below the second paragraph:

"If a Nar-Anon group or service committee has purchased an electronic version of CAL, the publication may be displayed during its own virtual Nar-Anon meetings or events. This limited permission is solely granted to the group or service committee purchasing the literature to perform only the functions of download, storage, retrieval, and transmission necessary for virtual meeting participants to view that publication on shared screens. No permission is granted to otherwise download, upload, photograph, record, copy, reproduce, store in or introduce into a retrieval system or transmit in any form or by any means other than as stated above."

"Before displaying electronic CAL publication(s) on a shared screen via this limited permission, a statement must be made to the participants that CAL publications copyrights prohibit copying literature from the screen."

Motion 2: In the Guide to World Services, section "Copyright and Trademark Information", insert the following text below paragraph 2:

"Nar-Anon groups and service committees may download electronic copies of literature that is posted on the Nar-Anon World Service Website, including both literature posted as text and as downloadable documents. Such CAL recovery literature may then be displayed during virtual Nar-Anon meetings or events. CAL service literature may be displayed during Nar-Anon service meetings. For review purposes, literature marked as "Fellowship Review" may be displayed during Nar-Anon service and business meetings. "Limited permission is granted to display literature, downloaded from the Nar-Anon World Service website, in Nar-Anon virtual meetings via screen sharing. No other permission is hereby granted to download, upload, photograph, record, copy, reproduce, store in or introduce into a retrieval system, or transmit in any form or by

any means other than as stated above."

"Before displaying downloaded Nar-Anon publication(s) on a shared screen, a statement must be made to the participants that Nar-Anon copyrights prohibit copying literature from the screen."

Motion 3 was dropped.

Motion 4: The fourth motion is to add words to the first paragraph of the GWS section regarding World Service Conferences to add words for the WSC to be annual and virtual.

Motion 5: The fifth motion was merged in with the fourth motion.

Motion 6: The sixth motion recommends changing the GWS to exempt the 20 Questions from the current limitation that says only 25% of an article may be shared Motion 7: The seventh motion says: "Ensure new CAL, including translated literature, is

made available in electronic format and existing CAL, including translated literature, is progressively reformatted into electronic format."

Motion 8: The eighth motion has been dropped.

Motion 9: Floor Motion 9 recommends tabling 2021 WSC Motions regarding recovery literature and authorizing the WS Literature Committee to assess, and implement, reject, or amend updates to recovery CAL.

Motion 10: Floor Motion 10 recommends tabling 2021 WSC Motions regarding the GWS and GLS and authorizing the WS Policies & Guidelines Committee to assess, and implement, reject, or amend updates to the GWS and GLS.

Motion 11: "Motion to "Amend Something Previously Adopted" by changing the name of the "prayer composed at WSC 2016" to "Third Step Prayer" in the 2016 Minutes regarding floor motion #3 and in the 2018 WSC Minutes on motion #3"
