#### A) Delegate Notice

"Effective May 8, 2021, Teri M resigned as CCR's Delegate. Teri stated that she decided to "take a break from service at the regional level." She also stated the 2018-2021 WSC cycle has been an extraordinary experience, and that "It has been an honor to represent our region over these many years as Alternate Delegate and then Delegate. I am grateful for the opportunities for growth and knowledge I have experienced and gained since I was entrusted to serve at the Regional level." She said, "My journey in Nar-Anon will continue".

Given this event; on Page 20 in the Nar-Anon Central California Region Guide to Regional Services - Regional Structure it states:

#### **Removal and Resignation of Officers**

If removal or resignation occurs, that position shall be filled on an interim basis by the RSC majority vote and presented at the next RSA for confirmation.

Also, on Page 29 under Regional Structure it states:

#### **Regional Delegates**

Delegate and alternate delegate are elected to serve for two years. Delegates are elected at the Elections RSA. The term of service begins when the region's bank accepts the transfer of leadership to the newly elected RSC officers. The alternate delegate should be willing to become delegate at the end of the delegate's term. In the event the delegate is unable to fulfill their duties the alternate delegate becomes delegate in an interim capacity and may continue to serve two subsequent full terms.

Given that Teri resigned as Delegate, and since JT is the Alternate Delegate, she has said she is willing to serve as Interim Delegate for the remainder of Teri's two-year term. A motion from the RSC will be needed to approve JT as Interim Delegate until the next RSA, when a motion from the Assembly will be needed to approve.

Michael – read out the above narrative.

J.T. – confirmed she is still open to being the interim delegate.

Motion to approve J.T. as the CCR Interim Delegate.

Michael – already sent an email to Teri to express gratitude. Robert felt this was enough. We now need an alternate delegate.

J.T. – does not have anyone in mind at this time.

#### B) Discussion of Hybrid Meetings

Robert – is anticipating groups are going to ask for help in hybrid meetings. Regarding Southern California Groups, there are four that are trying the hybrid approach. There is a mixed response. One meeting decided that remote attendees may listen, but not share. Groups seem to be struggling with the technology. It is a challenge to allow all to hear each other and to allow members an equal opportunity to share. Audio tends to work better than video, from experience with CCR Assemblies.

J.T. – has not heard the desire to go hybrid from groups in the CCR. There are two inperson meetings: Friday and Wednesdays. J.T. asked if anyone knows of a hybrid group? No one knows of a CCR hybrid group.

There tended to be audio problems with the hybrid approach in Hollister in the past. The Sunday meeting is permanently virtual and will not be going back to hybrid.

Les – shared there are several members that regularly attend the Friday, Santa Barbara group that come from outside the geographic area.

Michael – said the Atascadero meeting space has not reopened.

Robert – remembered we were not ready for the lock-down. He wanted to be prepared for the reopening.

Michael – ask if the World Service Conference was a hybrid.

**Robert – explained the Conference was totally virtual.** 

Les – asked how the RSC met before lock-down?

Robert – explained we met via Skype and Free Conference Call (audio-only). The RSC was never an in-person meeting.

Janet – said the church the two Salinas groups meet at has informed them the church is no longer inviting outside groups into the church. The groups are in the decision-making process around how to move forward.

Michael – noted that once again we are in a transition.

Ruth – offered that Monterey County just entered the "yellow-tier." On June 15, the State of California will abandon the tier system and the state will open up. Hybrid teaching is difficult at best. Hopefully, the venues will reopen and offer rooms to the groups once the state opens back up.
