Regional Chair's Report

Assembly Report from the Central California Regional (CCR) Chair

Hello from the Regional Chair,

Consensus Based Decision Making

Michael had led us through the troubled times as we shifted from meeting in-person through the lock downs to a time when we can again choose to meet in-person or online. With Michael's help, we had adapted.

I became chair of this region in September 2022. Everything was working great. I thought this would be a quiet time and we could make some small improvements. I began working with the Regional Service Committee to try using a group conscience within our service structure. The old way is based on how the government works and it is called Robert's Rules (someone else named Robert).

The way most other Twelve Step fellowships now work is called Consensus Based Decision Making (CBDM or KBDM). This quiet time would be a great time to experiment with CBDM.

Financial Situation

Then, suddenly, we were into a new crisis. The World Service Office announced they were having trouble paying their bills. Many committees throughout the world met to try to find ways to help. The Delegate and I were on various committees for world representatives. Other members in our region worked with the World Service Budget and Finance Committee. We sent emails, we offered to help, and then we waited. The crisis continues, but there is no evidence yet to show that anything is changing. It is as if the World Service Office is asking us to just keep on giving more, and more, but doesn't want us asking questions about where the money is going.

We also noticed that we seem to be receiving fewer services from world service. In response, members in our region are now involved in providing services we had previously hoped the world structure would provide. Members in our region are now involved in providing translation support for multi-national meetings and providing email services to help the regions communicate with each other.

I think we should take these extra expenses into consideration when we review our 2023 budget. Please refer to the next page in this report.

World Service Conference (WSC)

We are still experimenting with CBDM. We are still providing services to fill the gap left by world services. In addition, our region is heavily involved in preparing for the 2023 WSC. We are working with the Western Regions Committee on three things:

- YouTube presentations on the 2023 CAR youtube.com/@WRCNFG.
- A website with a proposal to streamline the 2023 WSC bit.lv/agree-not-argue.
- A Zoom convention at 9:00 am on February 11, 2023 use the Rocky Mountain "purple button".

Please check the YouTube presentations. We hope every member can spare a couple hours to become familiar with the WSC and the decisions we need to make. I am sure our Delegate will have more to say on this topic.

What's Next

This program has taught me I can find peace and serenity even in troubled times. Our groups are the heart of our region and they will continue to offer welcome and recovery to our members and the newcomers. Regardless of what happens with the financial situation, or the WSC, our groups are our hope.

Thursday Sweet Serenity (BACK IN PERSON for the past 18 months) Group Report #131-030

Salinas

FOR: January 28, 2023

History: The group began meeting in April 2011. Meetings moved from First Methodist (second location) to Lincoln Avenue Presbyterian in August 2016. With the pandemic in March 2020, our Salinas Sweet Serenity group was <u>suspended</u>. Half our group opted to go to the Salinas Monday Night Serenity virtual meetings while the other half wanted to meet back in person once the pandemic sanctions were lifted. So our FIRST in-person meeting was held again on July 15, 2021 at 6:30pm at our new location (Active Seniors Center (ASC) at 100 Harvest Street in Salinas). There were 5 members attending and we were grateful to be meeting back in person! (2 newer members had not yet attended an in-person meeting.) Our new location requires vaccinations to attend and at least one Nar-Anon member from each meeting must also be a member of the Active Seniors Center.

Attendance: Before our meetings were suspended due to the pandemic, meeting attendance was stable with an average of 8 people. Our FIRST in-person meeting on July 15, 2021 had 5 people attending. Our average attendance has been down to 4 for the past year. At this time, meeting again in person now, we do have a Secretary, a Treasurer, and a GSR as well. We have had a few newcomers here and there.

Format: A step is read and discussed during the fourth Thursday (using the yellow step booklet) and the daily reading from the SESH book other weeks. Another piece of conference approved literature (CAL) is selected when there is a fifth Thursday.

Treasurer's Report: The group's balance is \$160, not including the prudent reserve (\$150) and GSR funds (\$50). Donations have been sent since we began taking donations again on July 15, 2021 (after 19 months of no donations). Monthly rent is \$50.

Successes, Challenges and Positive/Negative Impacts of the pandemic:

- We are not getting new members the way we were before the pandemic hit and we are still a smaller group now since we began meeting again in July 2021.
- + Some previous members who attended (before the pandemic began) still have not returned, but we did hear from one recently (who may be able to come back in person to attend).
- + Our ASC (Active Senior Center) location is working out ok, but it may not be as welcoming for younger newcomers.
- + Those of us who attend do appreciate being able to meet in person again.
- + We are looking for ways to grow our meeting. We have posted a flier about our meetings at our venue location (Active Seniors Center ASC). We are patient.

I have not pursued a reimbursement from NA for the \$450 room cost. However, we were told that NA may not break even with their costs of flying out speakers and the hotel costs. We can consider the room fee as a gesture of cooperation and unity.

I wish to thank the members of the subcommittee for attending the meetings and participating in the process, especially Co-chair and Secretary Janet, and Kim for her graphics expertise. Also thank you to all our friends who agreed to speak and serve at the event.

Zoom: Still experiencing login issues for groups. This problem is starting to ease up. Zoom has released two-factor authentication despite many, many protests from users. Two-factor authentication takes time to resolve, as required by Zoom. Research is ongoing to find a solution. If any member has a solution, please let us know.

Zoho Email Accounts: TSS would like to offer each group its email account using the naranoncentralca.org domain. An example <u>is candlelight@naranoncentralca.org</u>. Narateen Subcommittee Report, January, 2023

After the Regional Assembly approved the Narateen Safety Guidelines and Handbook at our July Regional Assembly, we submitted them for approval to the World Service Narateen Committee. They were reviewed and returned with notes for two minor corrections, which were made, and in September, the Guidelines were approved. Since then, the CCR Narateen subcommittee has been working with the Southern California Narateen subcommittee and the WS Narateen Committee to work towards establishing Narateen in our region.

In September we participated in an informational workshop presented by SoCal Narateen to answer questions for Nar-Anon members interested in becoming Narateen facilitators. The CCR Narateen subcommittee has improved our Narateen page on the Central California Nar-Anon website, added an auto reply to our Narateen email, and personalized the Narateen outreach flier.

Seeing a need for more communication, Alijah started an informal WhatsApp group chat for those members in service in Narateen and it's been well received by other facilitators around the world. Sunny also participates on the World Service Narateen Committee.

Recently there have been two new Narateen items posted on the WS website for fellowship review: a Narateen Safety Handbook and a Facilitator Training Slideshow. These are available to download and we encourage all groups to do so.

The Narateen subcommittee asked the RSC to consider whether we could apply for DOJ livescan services using the Region's EIN tax number, so we could establish our own process for fingerprinting and approving facilitators in Central CA. We had asked and been told by the world service that we were not allowed to use the World Service EIN. It turned out that CCR does use the World Service EIN, and its non-profit status, for our bank account. Perhaps in the future CCR may consider getting our own nonprofit status, but for now, CCR Narateen does not have permission to use that number. For that reason, we needed to get our own EIN for Narateen. Scott C applied for and received that number for us and we are now in the process of applying for the DOJ fingerprinting account, which may take some time. As a side note, we were given a Narateen budget at the last Assembly, and told if we found we needed more, to let you know. We will need to ask you to increase our budget since we had to apply for the EIN, and we now are also applying for the DOJ account. We hope that the Region's GSRs approve of our decision to have our own fingerprinting. Neither Alijah nor Sunny have been able to get fingerprinted through the Southern California Narateen Committee, as they are having slow progress.
